Dear Readers,

Hands off my right to strike!

In its recent proposal regarding the 'Monti II' regulation, the European Commission opted for an approach that weakened the right to strike. This text had been eagerly awaited by the trade unions, because it was supposed to correct the problems created by the Laval and Viking cases. Yet, contrary to the commitments made by President Barroso to combat social dumping, the proposed text threatens to damage workers' rights and social Europe even further. What is under fire now, is the right to conduct collective action. Economic freedoms and the rules of competition must not be allowed to ride roughshod over fundamental rights. We demand that collective action is not hampered by European law. Now, it is up to the Parliament and the Council to correct this.

This debate reveals a trend which is unfavourable to social Europe. As we have witnessed throughout these crisis years, the temptation to sacrifice our social model on the altar of competitiveness is strong. In practice, it translates into austerity measures, repeated attacks on social rights and against the welfare state, as well as deregulation and sanctions. One need only look at the economic and social situation in certain countries to understand that this approach is not working, and is causing untold social damage. In spite of this virtually unanimous observation, Europe's leaders are relentlessly pursuing this agenda.

Europe must take a different path, developing alternatives to austerity. You cannot govern by relying solely on budgetary orthodoxy, as is the case at present. The European trade union is calling for a European social contract which would give priority to quality employment, in particular for young people. A country that fails to invest in its youth is jeopardising its own future. The trend towards austerity urgently needs to be reversed, in favour of a plan for economic recovery and sustainable growth with clear objectives, such as investments in an ambitious industrial policy for Europe. This is the message that we sent out at the recent meetings with Chancellor Angela Merkel as well as with the Danish Prime Minster and current president of the European Union's Council, Helle Thorning-Schmidt.

Support from labour interests for the European project can only be ensured by choosing the path of a fairer Europe where growth goes hand in hand with social cohesion and solidarity. The European trade unions will continue to mobilise, in order to achieve this objective.

MAJOR MEETINGS

ETUC Executive Committee

06-07/03/12 - The Executive Committee of the ETUC met in Brussels. The crisis was the main subject of discussions. An urgent declaration on the situation in Greece was adopted. The Committee also discussed and adopted a resolution on the Annual Growth Survey 2012, on collective bargaining, on anticipating change and restructuring as well as on the future of European Company Law. Some news should be noted on ETUC membership. The Executive Committee gave the green light to demand for membership by the Polish Trade Union Forum (Forum Związków Zawodowych) which became the 85th member of the ETUC. Indeed, three trade unions obtained observer status: the Confederation of Free Trade Unions (KSS) of the Former Yugoslav Republic of Macedonia, the Union of Free Trade Unions of Montenegro (UFTUM) and the Confederation of Trade Unions of Montenegro (CTUM).

Deep concerns about trade union freedoms

08/03/12 - The ETUC has written to Baroness Catherine Ashton, EU High Representative for Foreign Affairs and Security Policy, to express its deep concerns at recent developments on trade union freedoms in Egypt. The ETUC demanded EU to intervene urgently with the military government of Egypt to annul the 26 February sentence against Kamal Abbas, general coordinator of the Centre for Trade Union and Worker Services (CTUWS), who was unfairly sentenced, in absentia, to six months imprisonment for "insulting a public officer". "This sentence is an attack on freedom of expression but also on Egypt's independent workers' movement" said Bernadette Ségol.

Tripartite Social Summit:

for an investment policy to create decent jobs

01/03/12 - On the day after the European Day of Action, the ETUC took part in the Tripartite Social Summit on employment and growth. The European trade union delegation called directly on EU leaders to change course at once. The ETUC called for a European stimulus plan to develop a sustainable economy and to create quality jobs. For the European trade union, the social partners must be involved in any policy geared to the labour market and it is consequently vital for their independence to be respected.

ETUC's opposition to the adoption of the permanent austerity treaty

02/03/12 - At the margins of the Spring European Council, Heads of State and Governments signed the "Treaty on stability, coordination and governance in the economic and monetary union". The ETUC stressed that it opposes the new treaty as this will impose even greater budgetary austerity in Europe and hamper the recovery of employment. The European trade union deplored the fact that growth and employment were not the focus of detailed commitment in the same way as budgetary rigour.

No to undermining the right to strike

21/03/12 - The ETUC rejected the proposal for a "Monti II" regulation adopted by the European Commission. For the European trade union, the text unfortunately falls short of correcting the problems brought about by the Viking and Laval cases. "The right to take collective action is a fundamental right which must be guaranteed", said Bernadette Ségol. Indeed, the ETUC considers that measures to improve the implementation of the Posting of Workers Directive are not sufficient to fight social dumping, an objective that European Commission President José Manuel Barroso himself committed to take.
