1. EUROPEAN GROUPING OF TERRITORIAL COOPERATION (EGTC)

a) Presentation of the state of play by Krzysztof Nowaczek, Director, Committee of the Regions.

At the conclusion of the discussion, it was agreed to maintain/establish contact with the Committee of the Regions with a view to developing cooperation in the field of European Groupings of Territorial Cooperation. It was also agreed to discuss in detail the results of the questionnaire, to which nine IRTUCs responded, at the following meeting of the Coordination Committee.

Following this initial contact, it was agreed that the IRTUC representatives would be invited to the first European Conference of Regional Labour Market Observatories, to be held in Marseilles on 6 and 7 October 2010.

3. IRTUC WORK PROGRAMMES

 Presentation of the reports by IRTUC representatives in the Executive Committee and of the ETUC committees and working groups.

It was agreed that, in the future, the IRTUC representatives would turn in a succinct written report, which the Secretariat will then transmit to all the IRTUCs.

b) Further action on the project, "IRTUC – Coordination of collective bargaining – Cross-border cooperation"

It was agreed that the ETUC Secretariat would present a proposal for a second project to the Commission with a view to continuing this activity, on the basis of the conclusions adopted at the final conference.

A number of IRTUCs expressed an interest in participating. The ETUC Secretariat will send out a circular on this to all the IRTUCs.

4. EURES

a) Revision of the EURES Charter – Presentation of the state of play

It was noted that the ETUC's principal amendments had been accepted in the framework of the consultation launched within the EURES network.

However, as part of the consultation carried out by the Advisory Committee on Freedom of Movement for Workers, the ETUC Secretariat has tabled again the amendment on the permanence of the EURES cross-border partnerships.

> b) Draft resolution tabled by the IRTUC Coordination Committee on the role of trade unions in matters of workers' mobility in Europe

Following a presentation and discussion of the draft text, it was agreed to transmit the amended text, attached hereto, to the IRTUC presidents for approval.
