Employment Status Ambiguity: Many platform workers face uncertainty regarding their employment status, leading to a lack of access to basic rights and protections.





Exploitation Risks: Without proper oversight, platform workers can be vulnerable to unfair working conditions, such as unpredictable hours, low pay, and lack of benefits.




Isolation and Fragmentation: Platform workers often work in isolation, making it difficult for them to organize, communicate, and collectively bargain for better conditions.
